#### RE: APPROVAL OF ADDITIONAL CONTINGENCY AUTHORIZATION FOR THE FULLERTON ROAD GRADE SEPARATION PROJECT

#### **RECOMMENDED ACTION**

Authorize the Executive Director to execute and approve future change orders of up to \$16,219,798 with Skanska USA for the completion of the Fullerton Road Grade Separation Project, resulting in a maximum contract value of \$124,789,798.

#### BACKGROUND

In July 2021, the Board authorized a contract with Skanska USA for the Fullerton Road Grade Separation Project in the City of Industry ("Project") in the amount of \$108,570,000. Notice to proceed was given in August 2021.

Throughout the course of the Project, there have been numerous design revisions and delays. First, Union Pacific Railroad ("UPRR") required that the Project adhere to current design standards (2021) as opposed to the 2004 standards that were in effect when the Project contract was first awarded in July 2021. As you may recall, that contract was awarded to Shimmick Construction, which ultimately suspended work on the Project in the spring of 2020 in a dispute with the SGVCOG on change orders. That contract was ultimately mutually terminated and then awarded to Skanska to complete the Project on July 2021. Application of the new design standards has resulted in several change orders and claims from Skanska.

In addition, in February of 2024, Kinder Morgan informed SGVCOG of its contention that the Project caused additional loading on its pipeline and casing that jeopardized their integrity and would require mitigation. Kinder Morgan's contention was made after the new mainline track had been reconstructed and was ready for UPRR to cutover from the temporary shoofly track. Although the SGVCOG disagreed with Kinder Morgan's contention and performed an engineering analysis showing no significant additional loading, UPRR refused to perform the cutover to the new mainline track without a mitigation plan in place to protect the pipeline. In response, SGVCOG's design team developed a concept for a concrete pad that was reviewed and approved by both Kinder Morgan and UPRR and installed in January 2025.

The change in UPRR design standards and construction of the Kinder Morgan concrete protection slab have significantly delayed the project and has resulted in additional change orders and claims for delay costs from Skanska. The CPCC has been kept appraised of the ongoing status of the Project via monthly status updates. Due to the various delays and design changes, the change order claims were anticipated. The Project is 70% complete and most of the 10% contingency amount



has been exhausted. The Project is now expected to be completed in March 2026. Additional funds are being requested to fund the delay costs and anticipated change orders.

### FISCAL IMPACT

Funds for the additional contingency are available through the sale of surplus property and the Metro Loan. The surplus property was acquired as part of the Project and funds from the sale thereof will go towards the Project. The preliminary estimate of value for the surplus property is approximately \$9,000,000 to \$10,000,000. The SGVCOG has entered into a loan agreement with Metro and secured an advance on future Measure M fund distributions. Funds are designed to be flexible and eligible for several projects, including this Project. The existing contingency built into the Loan, together with the surplus land sale, will cover the funding need. The Loan contingency is expected to grow as staff is successful in acquiring additional grant funding for other eligible projects.

#### BACKGROUND

Each month committee members receive an update on key programs. Committee members may contact staff for clarifications on any of the reported items prior to the scheduled meeting. The following are items of note since the last meeting:

#### I. **PROJECTS**

#### **Montebello Corridor Project**

The contractor is continuing roadway work on Greenwood Avenue and Montebello Way. Utility relocations are underway along the future alignment of the West and East Frontage Roads. Additionally, work in preparation for the retaining walls and shoo-fly has commenced. SGVCOG received the full execution of the Construction and Maintenance Agreement for the three at-grade crossings at Vail Avenue, Maple Avenue, and Greenwood Avenue. The Agreement was approved at the Montebello City Council on December 5, 2024. The temporary detour through surrounding jurisdictions is in place and Montebello Boulevard/Montebello Way have closed as of July 8, 2024. Staff provided a verbal update to the Montebello City Council on November 13, 2024, and will continue to update the community and City Council as construction continues.

#### **Fullerton Road Grade Separation Project**

KM required the City of Industry to execute an Encroachment Agreement to allow the construction of the protection slab to move forward. This has been signed by all parties.

Work has commenced on the concrete slab. Concrete was poured in January 2025. An official date for the cutover has not been provided by UPRR.

#### La Verne Gold Line Pedestrian Bridge Project

Staff continues to actively work on finalizing the NEPA documents in compliance with Caltrans requirements. Utilities potentially impacted by the project area have been notified through mail and direct communication with them has been initiated. Meanwhile, discussions regarding the Fairplex easement and easements on the Metro Parking station are ongoing.

#### **Turnbull Canyon Grade Separation Project**

Utility relocation work is ongoing, including efforts by SCE and Frontier. SGVWC designs for Phase 1 and 2 have been finalized and are now out for bid. Meanwhile, SS formwork installation for the manhole is progressing steadily. Temporary Construction Easements notices have been mailed to affected properties, and SGVCOG staff continues to actively notify businesses and property owners on these ongoing activities.

#### State Route 57/60 Interchange Improvements Project

Construction for the SR 57/60 Interchange Improvements continues. Contractor is currently working on construction of Golden Springs Drive undercrossing bridge stem and soffit, retaining wall foundations and footings along eastbound SR-60, storm drain relocations at various locations, roadway work on Grand Avenue, and utility relocations along Grand Avenue.
